Application Guidelines for Assistant Professors for Institute of Global Innovation Research (GIR)

1. Overview

TUAT established the Institute of Global Innovation Research (hereinafter referred to as GIR) in April 2016. We aim to create advanced innovative research results and to promote the development of the global and innovative human resources in science by providing them with opportunities for them to engage in research at GIR.

The appointees will be affiliated with GIR and will belong to one of the strategic research teams which are formed under the three key areas of "Food", "Energy", and "Life Science". Under the cooperation of either of the Institute of Agriculture or the Institute of Engineering, the appointees are expected to conduct international collaborative research, study abroad and write international co-authored papers (more than one first author paper and basically papers to be submitted to Q1 journals)

2. Recruitment Field

TUAT will hire several Assistant Professors in the following three key areas. We don't always expect to hire assistant professors in every field.

3. Qualifications

- An applicant who has completed or will complete the doctoral course* at TUAT by the start date of his/her employment. (Except for those who have completed a doctoral course without Ph.D. degree)
- An applicant who has a unique and leading-edge research plan in the recruitment field.
- An applicant who has an overseas research experience.
- An applicant who has obtained Ph.D. within 5 years prior to the date of employment. (Excluding the period of life event leave**)

*An applicant who is deployed in TUAT in case he/she has obtained or will obtain Ph.D. at United Graduate School of Agricultural Science, Cooperative Major in Advanced Health Science in Graduate School of Bio-Applications and Systems Engineering and Doctoral Course of the United Graduate School of Veterinary Sciences of Gifu University.

4. Research activity etc.

GIR Assistant Professors are expected to

- enhance activities of strategic research teams
- conduct international collaborative research, write international collaborative papers, and improve their own research ability through the GIR Study Abroad Program ***
- act as an operating staff of GIR symposium, research presentation, etc. organized by GIR

***Study Abroad Program: A period of approximately three months per year is encouraged, up to one year (maximum two times for a two-years-term, not across the fiscal years). GIR supports travel expenses (once a year), accommodation fee and daily allowance for up to 90 days. For a plan over 90 days, GIR will reviews the plan and may support expenses of the whole period for the excellent one.

5. Evaluation

Evaluation is conducted once a year on research contents, research performance and international collaborative papers.

6. Mentor

A member of a strategic research team is assigned as a mentor of an assistant professor. Please ask a member of the strategic research team to fill in the "Reference" field of Application. A mentor is requested to give an assistant professor help to prepare research environment (research budget, research space etc.), advise for research activities and support international collaborative research and writing international co-authored papers.

7. Salary and Working Condition

Salary will be decided according to the TUAT regulations considering the applicant's educational background and professional experience.

All conditions are in accordance with the Working Regulation and Salary Regulation of TUAT.

Working hours: from 8:30am to 5:15pm

Overtime: average 10 hours per month

Break: sixty minutes

Holidays: Saturday, Sunday, Public holidays, May 31 and form December 29 to January 3 Salary: more than JPY440,000 per month (annual salary system)

We will inform those who pass the document screening.
